Sub: Special Window for Re-Lodgment of Transfer request of Physical Shares - Report

In terms of Regulation 30 read with Schedule III and other applicable provisions of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, 'SEBI (LODR) Regulations' and SEBI Circular No. SEBI/HO/MIRSD-PoD/P/CIR/2025/97, we hereby give a reminder in continuation of our previous disclosure dated September 24, 2025 and the above referred SEBI Circular, the Shareholders are once again hereby informed that a Special Window has been opened only for re-lodgment of transfer deeds, which were lodged prior to the deadline of April 1, 2019 and rejected/returned /not attended due to deficiency in the documents/process or otherwise.
